Instructions for Using this fillable License Application form

General

This is a dynamic form which can be filled out on a computer using Adobe Acrobat Professional Version 7 or higher or Adobe Acrobat Reader Version 6.0.2 or higher. If you use Adobe Acrobat Reader to fill in the form, the contents you enter cannot be saved. Using either software you can e-mail the data you enter into the form to ASMC by clicking the e-mail button on the certtification page but you must submit the a signed and notarized original certification page, Networth statement or surety letter, and the required fee to ASMC before the application will be reviewed and considered for approval.

1. Hovering the mouse curser over some fields will display a tool tip with additional instructions.

2. Enter all dates as numbers in the fomat MMDDYYYY without hyphens, slashes or commas.

3. Social Security Numbers are required for all individuals except the Resident Agent for whom it is optional. Enter SSN as a 9 digit number without dashes. Social Security numbers will be kept confidential and not displayed in any version of this document which is made available to the public.

4. Employer ID number is required for all Business Entities. Enter as a 9 digit number without dashes.

5. Buttons are provided to allow the addition of sets of entry fields for each section to accomodate the number of persons or entities necessary to define the ownership and control structure of the Licensee, Mining operations related to the Licensee, and violation history of the Licensee. Add as many sets of fields for each section of the form as are necessary. The tabbing order for the form will change if you add sets of fields to a page. You must use the mouse to select the first entry field of an added set in order to tab within the set.

6. Some drop down fields include the choice of "Other:" If a choice is not listed that describes the appropriate answer to the field, select "Other:" and you may type in the appropriate response next to the word "Other" in the field.

7. Fields which require a written narative or description are expandible allowing multiple lines of text. As you are typing, the lines will scroll in the window. When you tab out of the field, it will expand to reveal all text entered.

8. In Part H, you must select the method of demonstrating Financial Qualification. Either the original Net Worth Statement or the Surety Letter must be submitted to ASMC.

9. E-mailing the data in the form does not constitute a completed submission of the Application. The application to ASMC is not complete until the original Networth statement or Surety letter, the original signed and notarized Certification page, and the required fee is received by ASMC and all deficiencies have been corrected. Please change the subject line of the e-mail to reflect the name of the company applying for the license.

Fees:

If this is an application for a New Coal Mining License, submit a fee of \$2,500.00. If this is an application for Annual Update, submit a fee of \$500.00. If this is an application for notification of change in ownership or control or violation history no fee is required. Fees must be submitted in the form of cash, certified bank check or money order.

General: Complete this application by typing or printing legibly in ink. If a question does not apply to the applicant, indicate this by answering "not applicable". On some questions, it may be necessary to attach additional pages. If so, indicate the question number and type "Page of " with the appropriate numbers on each additional sheet.

G. REVOCATION OR SUSPENSION OF PRIOR PERMITS OR FORFEITURE OF BONDS

H. FINANCIAL QUALIFICATIONS

An applicant for a coal surface mining license is required to demonstrate "sufficient financial responsibility" by either:

(ii)(A) a current statement in letter form, certified by a certified public accountant or public accountant

licensed to do business in the State of Alabama that the applicant has a net worth of

Not less than \$100,000. The statement must not be ambiguous, qualified or otherwise

vague. It must state the Alabama certificate number of, and be signed by the certified public accountant or public account; or

(B) by demonstrating the applicant's ability to meet the bonding requirements in

an amount of not less than \$1,000,000 by furnishing the State Regulatory Authority

a current letter of commitment from a corporate surety qualified to do business in

the State of Alabama to issue a bond in an amount of \$1,000,000 or greater; the letter

shall include a signed power of attorney if signed by an agent of the surety.

(Part 13.14(h)(2)(ii)(A & B)

The Commission will accept letters which are clear and concise. The letters should <u>not</u> be restrictive, qualified or ambiguous. They should speak to the requirements of the law.

Two suggested sample letters are found on the opposite page. We suggest the use of either to expedite consideration of this question. Both sample letters have been developed with assistance from C.P.A. and Surety representatives.

NO LICENSE WILL BE ISSUED WHERE THE LETTERS SUPPLIED DO NOT MEET REQUIREMENTS OF THE LAW.

The Commission will look for the following items in financial letters since these items are indicated as necessary by law:

CERTIFIED PUBLIC ACCOUNTANT/PUBLIC ACCOUNTANT LETTERS:

- 1. Should be current letter.
- 2. Should state the certificate number (Alabama #) of the C.P.A. OR P.A.
- 3. Letter should <u>not</u> be ambiguous, qualified, or otherwise vague. The letter must <u>plainly</u> and <u>affirmatively</u> state the existence of the required net worth, without qualification!
- 4. Letter must be signed by the C.P.A. OR P.A.

CORPORATE SURETY BOND LETTERS:

- 1. Should be current letter.
- 2. Should state the corporate surety "commits" (see regulations) itself to issue bond to applicant not less than \$1,000,000.
- 3. Letter should identify the corporate surety as qualified to do business in the State of Alabama.
- 4. Should have a signed power of attorney if signed by agent of surety.

Any letter failing to meet requirements of the law will cause the license to be held up pending an acceptable letter. We urge careful attention to the above guides.

Sample Letters are included with these instructions

I. TECHNICAL QUALIFICATIONS

This statement has resulted in a gross variance in the type and quantity of information, which is submitted in response to this requirement. To assist the applicants in preparing the forms and to reduce the time required for review and approval of the applications, certain items need to be addressed.

The following items are of the nature desired by the Commission in reviewing a license application for "sufficient technical skills":

- 1. Coal mining or related work history of key officers, partners, etc.
- 2. Coal mining or related work history of key employees, including reference to requirements for certified blaster and registered professional engineer and engineering laboratory work.
- 3. Names and business relationships of affiliated companies or individuals, e.g. subsidiary or parent corporations, or firms of common ownership, which will be involved in the surface coal mining operations.
- 4. Names of contract companies or individuals engaged to meet any particular requirements of the mining operations and the time frame of their employment, if known.
- 5. Any relevant information which demonstrates the applicant's ability to meet the technical requirements of the Act and regulations including the requirements of certification by a registered professional engineer, certified blaster, water sampling and testing, and various hydrologic, geologic and soil studies.
- 6. Particular reference to reclamation work at previous mining companies will be helpful where officers or partners have been in other companies.

NO LICENSE WILL BE ISSUED WHERE THE LETTERS SUPPLIED DO NOT MEET REQUIREMENTS OF THE LAW.

Any submission failing to meet requirements of the law will cause the license to be held up pending an acceptable demonstration by the applicant. We urge your careful attention to the above guides.
