The permit is revised as follows:

1. Update Part II Fish and Wildlife to remove ASMC Renewal Conditions 1 and 2.

- 2. Addendum to the Operation Plan to show the placement of spoil from Fishtrap Mine No. 2, P-3930 to Short Creek Prep, P-3200.
- 3. Addendum to the Operation Plan to include Surface Mining.
- 4. Addendum to the General Plan.
- 5. Add 5.0 Acres for Sediment Basin 013, Access and drainage course to Increment No. 1.

Revision 12 Findings 1: By comments dated July 25, 2024 and September 26, 2024, the U.S. Fish & Wildlife Service concurred the project is not likely to adversely affect the endangered Indiana Bat, Northern Long-Eared Bat and/or the proposed endangered Tricolored Bat if tree removal only occurs from October 1 through March 14.

Revision 12 Condition 1: The permittee may only conduct tree removal from October 1 through March 14.

Revision 12 Condition 2: If tree removal from the potential summer roosting habitat is necessary outside October 1 through March 14 timeframe an Indiana Bat, Northern Long-Eared Bat and/or Tricolored Bat (include the Tricolored Bat if added to the list of endangered species prior to tree removal) presence/absence survey must be conducted, and the U.S. Fish & Wildlife Service approval must be submitted to ASMC prior to tree removal.

Revision 12 Condition 3: No new disturbance can occur on the Ala-West, Inc., Shamrock Sustainable Investments, and the State of Alabama property until a new right of entry is obtained and turned into the ASMC.
