REVISION TO PERMIT FOR SURFACE COAL MINING OPERATIONS

Pursuant to the Alabama Surface Mining Control and Reclamation Act, Act No. 81-435, and duly promulgated rules of the Commission, revision is hereby approved for permit:

The permit is revised as follows:

- 1. Add 23 incidental acres to Increment No. 5 for the 3 West #1 shaft & powerline (21 acres) and access roads (2 acres).
- 2. Add 15 incidental acres to Increment No. 1 for the 2 west shaft pad (6 acres), degas boreholes (2 acres), access roads (7 acres).
- 3. Modify the general plan.
- 4. Modify the operation plan.
- 5. Update the Subsidence Control Plan.
- 6. Modify Breaker Rock Disposal Area No. 3.
- 7. To allow the breaker rock material to be carried off-site for construction projects.
- **R-59 Findings 1:** By comments dated November 7, 2023, the U.S. Fish & Wildlife Service concurred the project (area identified on the Revision R-59 Permit Map as being added to Increment No. 1 located within Sections 21, 28 and 33) is not likely to adversely affect the Indiana Bat and/or the Northern Long-Eared Bat if tree removal only occurs from October 15 through March 31.
- **R-59 Findings 2:** By comments dated May 3, 2024, the U.S. Fish & Wildlife Service concurred the project (area identified on the Revision R-59 Permit Map as being added to Increment No. 1 located within the SE/SW of Section 16) has no federally listed species/critical habitat known to occur in the project area. As described, the project will have no significant impact on fish and wildlife resources.
- **R-59 Condition 1:** The permittee may only conduct tree removal from October 15 through March 31 for the area identified on the Revision 59 Permit Map as being added to Increment No. 1 located within Sections 28 and 33.
- **R-59 Condition 2:** If tree removal from the potential summer roosting habitat for the area identified on the Revision R-59 Permit Map as being added to Increment No. 1 located within Sections 21, 28 and 33 is necessary outside October 15 through March 31 timeframe an Indiana Bat and Northern Long-Eared Bat

presence/absence survey must be conducted and the U.S. Fish & Wildlife Service approval must be submitted to ASMC prior to tree removal.

R-59 Condition 3: Prior to the bond calculation of Increment No. 5, the permittee must submit concurrence from the Alabama Historical Commission, US Fish & Wildlife Service and Alabama Department of Conservation and Natural Resources for the 23 acres being added to Increment No. 5 as identified on the Revision R-59 Permit Map.

R-59 Condition 4: Prior to the bond calculation of Increment No. 5, the permittee must submit approval from ADEM for a General Stormwater Permit for the 23 acres being added to Increment No. 5 as identified on the Revision R-59 Permit Map.

R-59 Condition 5: Prior to the bond calculation of Increment No. 5, the permittee must submit approval from the Jefferson County Zoning Commission to change the 23 acres being added to increment No. 5 as identified on the Revision R-59 permit map from A-1 to I-3S to allow surface disturbance.

All other terms and conditions remain in effect as well as all Findings in the original permit and any Findings appropriate for this revision.
