REVISION TO PERMIT FOR SURFACE COAL MINING OPERATIONS

The permit is revised as follows:

1. Add 0.4 acres to Increment No. 1 for Degas Borehole 54-2 (No acreage change).
2. Add 32.0 acres to Increment No. 5 for the 3 West No. 1 shaft site.
3. Add 1.0 acre to Increment No. 5 to widen the ancillary road access.
4. Modify the General Plan.
5. Modify the Operation Plan.
6. Request a waiver of the 100' stream buffer zone of Mud Creek.

R-61 Findings 1: By comments dated August 21, 2025, the U.S. Fish & Wildlife Service concurred the project is not likely to adversely affect the endangered Indiana Bat, Northern Long-Eared Bat and/or the proposed endangered Tricolored Bat if tree removal only occurs from October 1 through March 14. (Area added within Sections 16 and 17 as shown on the R-61 Permit Map.)

R-61 Condition 1: The permittee may only conduct tree removal from October 1 through March 14. (Area added within Sections 16 and 17 as shown on the R-61 Permit Map.)

R-61 Condition 2: If tree removal from the potential summer roosting habitat is necessary outside October 1 through March 14 timeframe an Indiana Bat, Northern Long-Eared Bat and/or Tricolored Bat (include the Tricolored Bat if added to the list of endangered species prior to tree removal) presence/absence survey must be conducted and the U.S. Fish & Wildlife Service approval must be submitted to ASMC prior to tree removal. (Area added within Sections 16 and 17 as shown on the R-61 Permit Map.)
