PART IV ADDENDUM TO RECLAMATION PLAN

- 1) The historic premining landuse (undeveloped) and the proposed post mining landuse for the new acreage to be added through the above referenced Revision R-12 (undeveloped/no current use and a permanent water impoundment) are compatible with the surrounding landuse and of the previously approved Permit P-3691.
- 2) No prime farmland exists within the area to be added through Revision R-12. Soil types within this new acreage are identical to the originally approved Permit P-3691.
- 3) Completeness of contouring, backfilling, and grading shall follow the same requirements as the previously approved Reclamation Schedule. All grading and contouring shall follow the approximate original contours.
- 4) Topsoil handling and revegetation for non prime farmland areas added through Revision R-12 will follow the originally approved Reclamation Plan in the Permit P-3691.
- 5) Husbandry practices and sampling to determine success of revegetation of all non prime farmland areas shall be in accordance with the originally approved Permit P-3691.
